About RedSTAR

RedSTAR is the volunteer wilderness special operations unit of Kentucky's Powell County Ambulance Service, covering the Red River Gorge. Comprised of professional EMTs, Paramedics, Nurses, and Physicians who donate their time and skills, RedSTAR supplies wilderness-capable medical providers to embed with area search and rescue teams during their operations. RedSTAR, Inc. provides these services as a not-for-profit contractor to Powell County Fiscal Court and maintains MOU's with several other agencies for operational support.

Organized in **2015** by veterans of Kentucky's SAR and EMS communities, we continue to grow year by year. In **2019**, RedSTAR conducted the first helicopter hoist rescue in Kentucky history with the 238th Dustoff unit. In **2021**, our members conducted the first high angle insertion of the 123rd Special Tactics Squadron's search K9 on a Kentucky deployment. In **2022**, RedSTAR began providing ALS crews to the Kentucky State Police Air Rescue Program, and conducted numerous wilderness medical hoists during the Eastern Kentucky Floods. Our members have been instrumental in designing the IBSC WP-C exam, and defining the qualifications, educational requirements, and scope of practice for Kentucky's Advanced Practice Wilderness Paramedics.

We provide high quality wilderness medical and rescue training to a range of local, state, federal, and military clients. Your course tuition helps support and sustain our volunteer operations!

About This Course

We believe that every technical rescue incident is an EMS call with complicating factors. Technical rescue should be patient-centered, medically directed, and meet standards of care.

This course is intended to achieve that goal by bridging the performance expectations of a rope rescue technician with delivery of organized, evidence-based healthcare.

Areas of emphasis in the technical rescue domain include use of lightweight equipment, the ability to improvise

rescue systems with limited equipment, and sound fundamental rope rescue skills. Areas of emphasis in the medical domain include general principles of care, therapeutic patient packaging, airway management, temperature regulation, pharmacological therapies, and low-resource assessment in challenging environments.

Course Location

The classroom portion of this course (Monday-Tuesday) will occur at **Middlefork Volunteer Fire Department** in **Stanton**, **KY**.

The hands-on portion of this course (Tuesday- Friday) will occur at **Red River Rescue training center**, **also in Stanton**, **KY**. Both locations are easily found on Google Maps.

Please note: Red River Rescue is a commercial business, located next to the home of owner Jeremy Urekew and

Kristen Gousse (pictured right). The training center is entirely outdoors, but Jeremy and Kristin graciously open their private home to students for the use of running water, bathrooms, and wifi. Coolers will be provided for storage of personal food and drink.

The hands-on training location features a tall amphitheater cliff, with a steep walk-up from bottom side to top that requires use of a hand line.

Required Gear

To successfully complete this course, you must bring with you:

- Climbing harness, with a Class III (full body) design being preferable. Class II (seat design) is acceptable if capable of accepting a torso addition.
- o Rope gloves
- Eye protection (e.g. safety glasses)
- Nitrile exam gloves in your size
- Rescue or climbing helmet
- Headlamp capable of being worn with helmet, and spare batteries
- Non-slick, closed-toe boots or approach shoes
- o Clothing layers appropriate for extended time in chilly weather and moderate precipitation
- Water, and a portable hydration capability
- Food for snacking throughout the day, clearly labeled with your name

Suggested Gear

These items are recommended for your comfort and ability to participate more fully:

- o Personal comfort items such as chapstick, sunglasses, etc.
- o Sunscreen
- o Bug spray (Permethrin or Picaridin for clothes, DEET or Picaridin for skin)
- OTC painkillers/anti-inflammatories
- Two-way radio with VTAC channels
- Action camera (e.g. GoPro)
- Power brick for charging personal devices
- Any personal rescue gear you wish to use, subject to course schedule and inspection/approval by course instructors.







A Special Note About the Course Schedule:

Though area restaurants are open for breakfast/coffee and dinner, you should prepare to have lunch on site at the training location. Though the home of Jeremy and Kristin will be open for use of the kitchen, their home is not designed as a commercial venue and access to microwave, oven, etc. will be inherently limited.

Devices such as camp stoves and backpacking coffee makers are suggested, to make best use of the lunch period. Though many restaurants and gas stations are geographically close, the two-lane back roads of the area mean that travel time to them may be 20-30 minutes each way.

The course will end at approximately noon on Friday, May 23rd. We encourage you to enjoy a bit of the Red River Gorge that afternoon!
